Abstract: The Horace Hagedorn Papers contain correspondence, audio-visual, photographs, and

materials relating to his company Stern's Garden Products (later renamed Scotts Miracle-Gro after the merger in 1995). Material includes newspaper clippings, magazine clippings, awards and citations, memorial journals, memorial album, cards, and event

programs. He was well known for his philanthropic work and donations made to

numerous charities, particularly those dealing with children.

Biographical History

Horace Hagedorn was born in Manhattan, NY on March 18, 1915 to Alfred and Blanch Rosenfelt Hagedorn. He earned a business degree from the University of Pennsylvanian in 1933. After graduation, he started in the representative business with Aerial Publicizing Inc. in 1934. A year later, he was Eastern Sales Manager of the Virginia Broadcasting System. In 1936, he operated his own radio station representative business before joining the Howard H. Wilson Company in 1937, where Hagedorn managed the Eastern office in New York City. In 1946, Hagedorn was key in the development of a radio drama, "The Big Story": a crime-drama series.

In the mid-1940s through his work in advertising he met Otto Stern, who had come in to buy radio advertising time. Both he and Hagedorn hit upon the idea of fertilizer, and the work of Rutgers University professor, O. Wesley Davidson. They hired him to develop a water-soluble fertilizer. Mr. Hagedorn's first wife, Peggy, came up with the name Miracle-Gro and the company was founded in 1950. After four years of success Mr. Hagedorn decided to leave his advertising career to work at Miracle-Gro full time. In the mid-1980s he bought out Mr. Stern. The growth and popularity of his product Miracle-Gro was due to Mr. Hagedorn's marketing genius.

When Mr. Hagedorn merged his company with O.M. Scott & Sons in 1995, he took \$50 million he personally earned from the sale to set up a charitable trust. Among many donations, most of them made for children's causes, contributions to Hofstra University's school of education, which is now named for him, and to Adelphi University's business school, which also carries his name. The Horace and Amy Hagedorn fund contributed more than \$26.4 million to 330 nonprofit organizations since 1997 through the Long Island Community foundation, which distributes charitable donations. He got special attention when he supported the education of 50 underprivileged Brooklyn schoolchildren, with the goal of sending them to college.

Hagedorn had four sons, James, Peter, Robert, and Paul, and two daughters, Susan and Kate. He married Margaret O' Keefe in Manhasset in 1941, who died in 1984. He later married Amelia Maiello, prekindergarten teacher who he met through a personal ad in a local paper in 1986.

Horace Hagedorn died in his sleep at his Sands Point, N.Y. home on January 31, 2005, of pulmonary fibrosis at the age of 89. A memorial celebration of his life was planned for March 2005.

Scope and Content of the Collection

The Horace Hagedorn Papers contain correspondence, audio-visual, photographs, and materials relating to his company Scotts Miracle-Gro. This material includes newspaper clippings, magazine clippings, awards and citations, memorial journals, memorial album, cards, and event programs. The dates range from 1949-2011. Correspondences include personal and business. Scotts Miracle-Gro information included advertisements, products, correspondence, stationary and letterheads, business cards, speeches, event information, and programs for various functions that were attended. Collections include multiple awards and citations for philanthropic work and business, newspaper and magazine articles outlining Hagedorn's career and life, from 1987-2011, photographs of Hagedorn throughout his life with colleagues, family members, and individual pictures. Audio-visual materials include DVDs, cassette tapes, DVD-R, and photo disks. VHS tapes containing footage for the 2004 film *Meet Mr. Miracle-Gro: The Horace Hagedorn* Story is also included in the collection. Also included is further information about his philanthropic efforts, such as contribution information, news articles, organization correspondence and appreciations, and a memorial fund set up in his name. Included are correspondence to Amelia Hagedorn upon his death, as well as sympathy cards, memorial journal, memorial photo album, and slideshows highlighting his life.
