- 2. Demonstration Space Update
  - a. Policy approved by BOT.
  - b. Four locations.
    - Swirbul Plaza Primary location
    - Flagpole Lawn
    - Levermore Lawn
    - UC Center Plaza

- 3. Authentic Voices Video
  - a. 12 students responded and 5 interviews completed.

## 4. ICE Protocol

- a. Document distributed. Legal counsel has reviewed.

- c. Agreed that all offices including International Student Services refer any ICE agent to Executive Vice President for Finance and Administration.
- d. Suggestion on adding-ICE, FBI and FISA court to the heading of document.

## 5. Immigration Fund

- a. To help students in need for housing, travel, legal fees, etc.
- b. There may be universities who have such funds. Group agreed to look into the different schools who have a fund and research criteria.

- c. A student organizer has contacted Rory Shaffer Walsh in the Office of University Advancement to inquire about an Immigration fund.
  - He has been asked to attend the DII Taskforce meeting.
- 6. Hofstra Law Services Update
  - a. Not up and running yet. Currently interviewing lawyers at the moment.
- 7. Sanctuary Campus Status
  - a. CNN Article ICE Increasing scrutiny for sanctuary cities and places.
  - b. 1% of colleges & universities are sanctuary campuses.
  - c. Taskforce discussed concerns about declaring sanctuary status.
  - d. Compared to other "sanctuary" campuses, Adelphi provides the same and sometimes even more services and support to our undocumented students.
  - e. We discussed the misconception of being a "sanctuary campus"
    - Sanctuary campuses protect and stand by their students up to a certain point. Once college or university is presented with warrant or subpoena they will cooperate with government.
  - f. How do we clarify the true definition of sanctuary to campus?
    - The idea of creating a visual graphic to illustrate the actions taken by "sanctuary" campuses <u>vs.</u>and Adelphi.
  - g. Sanctuary Campus in Concept: Responses and Resources Handout
    - Agreed to reword document. Need to find words that convey our commitment.
- 8. "Refugees/Immigrants Welcome Here" Safe Zone initiative
  - a. "Safe Zone" phrase may be misleading? Need to find words that associate a confidential space that makes one feel safe on campus.
- 9. Agreed to discuss housing accommodation options for students at the top of next week's agenda.
