II.	PAYMENT CATEGORY Fill in applicable totals a. Teacher training for two (2) teachers at a cost of \$500.00. b. Lego Robotics Kit for competition use, \$300.00 per kit. c. Team registration for competition, \$200.00 per team.

III. ADELPHI UNIVERSITY RESPONSIBILITIES AND COMMITMENTS

- a. Engage school district teachers in a one day training to enable them to mentor their students for the competition/conference. If applicable.
- b. Purchase one (maximum of two) Lego Robotics Kits for use by district students and teachers. If applicable.
- c. Host the conference onsite at Adelphi on May 7, 2016 for middle school students. If applicable.

IV. SCHOOL DISTRICT RESPONSIBLITIES AND COMMITMENTS

- a. Provide a maximum of two teachers per school for the one day training, December 4, 2015
- b. Commit to a middle school team that will take part in the May 7, 2016 competition.
- c. Provide classroom or other space for the robotics team to meet.
- d. Ensure that the robotics team meets on a regular basis and produces a robot for the competition.
- e. Provide transportation for students to the competition.
- f. Provides Adelphi University with payment to cover the costs of Lego Kit purchase, teacher training and conference support, to the sum shown in section II.

V. MODIFICATIONS – TERMINATION OF AGREEMENT

- a. No modification of this Agreement will be valid unless written in the form of an addendum or amendment and signed by both parties.
- b. Breach of conditions of this Agreement by either party will provide cause of termination of the Agreement
- c. No Termination of Agreement will be valid unless provided in written form no less than 60 days by either party and signed by both parties.

VI. BILLING AND PAYMENT

- a. The estimated cost of performance of this agreement during the budget period October 2015 through May 2016 is \$1,000 per school. Payment will be sent to Ms. Sabita Nayak, Adelphi University, Social Work Building, Room 118, Garden City, New York 11530. The district must provide payment before the Lego Kits are purchased and before any teacher training takes place, which is scheduled for December 4, 2015.
- VII. Each of the parties to this agreement agrees to hold the other parties to this agreement harmless from any and all claims, suits, demands of judgments, including reasonable attorney fees, which arise out acts of omission from the respective parties.
- VIII. THIS INSTRUMENT REPRESENTS THE ENTIRE AGREEMENT It is expressly agreed that this instrument represents the entire Agreement of the parties and that all previous understandings are merged in this Agreement.
