## Independent Student: Verification of 2018 Income Information

### INSTRUCTIONS:

You, the student (**and spouse if applicable**), must check the box that is applicable to your 2018 federal tax filing status. The best way to verify tax information is by using the *IRS Data Retrieval Tool (IRS DRT)* that is part of *FAFSA on the Web* at [fafsa.gov](http://fafsa.gov). In most cases, no further documentation will be needed to verify 2018 tax information that was transferred into the student's FAFSA using the *IRS DRT*.

Notify the financial aid office if you and your spouse filed separate federal tax returns for 2018 or had a change in marital status after the end of the 2018 tax year (December 31, 2018).

### CHECK THE BOX THAT APPLIES:

- Did you, the student (and spouse, if applicable), work in 2018?
  - Yes – Continue to question 2
  - No – I did not work or earn any wages from employment and neither did my spouse (if applicable) – Continue to the Certification and Signatures section (Do not answer questions 2 or 3)
- Did you, the student (and spouse, if applicable), file a 2018 Federal Income Tax Return?
  - Yes – Continue to question 3
  - No – Continue to the Employment Information and Certification and Signatures sections (Do not answer question 3)
- Did you, the student (and spouse, if applicable), use the Data Retrieval Tool (DRT) in FAFSA on the Web to transfer 2018 tax return information into your FAFSA?
  - Yes – Continue to Certification and Signature section
  - No – But I will submit a signed copy of my 2018 Federal Income Tax Return, all 2018 W-2s AND all applicable schedules. If you filed a separate return from your spouse (if applicable), you will also need to submit a signed copy of their 2018 Federal Income Tax Return, all 2018 W-2s AND all applicable schedules. Continue to Certification and Signature section.
