## EMPLOYMENT FOLLOW UP SURVEY INITIAL PROGRAMS 2021-2022 ACADEMIC YEAR

A follow-up survey was electronically distributed to the 187 graduates in October-November 2022, who met either of the following: 1) did not complete the Exit Survey 2) did not have employment at the time of May 2022. The aim was to track employment statuses 5-6 months post-graduation. **26 out of 187 graduates completed the Employment Follow-up Survey for a response rate of 14%.**

*The first question asked graduates if they are presently employed in the education field.*
