Unemployment Insurance Benefits

The "CARES Act" affects unemployment insurance, as well. The new law:

- Extends eligibility for individuals who have traditionally been ineligible for UI benefits (e.g., selfemployed workers, independent contractors);
- Allows for an additional \$600 per week, on top of regular benefits, to all UI recipients; and
- Provides an additional 13 weeks of UI benefits, beyond the regular 26 weeks already provided, for a total of 39 weeks of coverage.

FEMA Assistance

Private Non-Profit Eligibility (PNP) Guidelines

Facilities not owned by public entities also may be eligible for disaster assistance if certain criteria are met. This program is intended for organizations that have sustained extensive disaster losses. PNP facilities fall into two categories:

- 1. Critical PNPs a facility that provides a critical service which is defined as: education, utility, emergency, or medical.
- 2. Non-critical PNPs a facility that provides a non-critical, but essential, government service AND is open to the general public such as: community centers, museums, and zoos.
