Her work aims to address the structural inequalities impacting minoritized women navigating violence and economic insecurity.

Her professional experience spans mezzo and macro-level social work, from leading local and statewide social justice and policy advocacy campaigns as a community organizer to supervising a youth program and coordinating hotline services for immigrant survivors. These experiences continue to shape and inform her research and commitment to advancing community well-being.

Jasmine Infante-Cruz, LMSW, is a social worker with over 20 years of experience in the field. She earned her Master of Social Work degree from Adelphi University, where she is currently pursuing her PhD. As a bilingual school social worker for the New York City Department of Education, she provides counseling, case management, and crisis intervention services to high school students with disabilities.

Jasmine's career includes significant roles such as a behavioral health social worker at the NYC Health and Hospitals Corporation, where she managed court-ordered mental health services for adults. Additionally, she worked as a bilingual social worker at an outpatient school-based mental health clinic, delivering therapy and crisis intervention while conducting comprehensive assessments for adolescents.

# Caitlin Compton-Almo

Caitlin started her journey in higher education as a psychology major at Suffolk County Community College before transferring to the University of Scranton, where she earned a BS in Human Services with a concentration in Human Development in 2002.

Caitlin earned her MSW with a specialization in Children & Families from Fordham University in 2004. She has held a variety of positions as a social work practitioner, including school based social worker, residential supervisor for a program serving homeless families with disabilities, and outpatient mental health clinician. Most of her social work experience was dedicated to working with youth placed through the juvenile justice system, where she engaged in case management, staff training, program administration, clinical work with individuals and families, and facilitated psychoeducational groups. Caitlin has been teaching full time since 2016, and has taught at the Associate, Baccalaureate and Master levels having instructed each of the human services classes at Suffolk County Community College, as well as the full research sequence as an adjunct faculty member at Adelphi University's School of Social Work. Caitlin's dissertation employed an ecosystems perspective to a case study of the transfer process for community college students seeking a BSW degree. Dena was recruited as a Senior Research Scientist for the AJ Drexel Autism Institute last August. She is an appointed member of the Interagency Autism Coordinating Committee (IACC) advising the White House on autism research priorities.

She is a member of the Autism Intervention Research Network in Physical Health (AIR-P) working with the Gender, Sexuality and Healthcare Node. She is also a member of the board of directors' Executive Committee for the Institute for Exceptional Care (IEC). She has published multiple book chapters and journal articles and her presentations include both policy and autism-related events world-wide Her awards include the Cathy Pratt Professional of the Year Award from Autism Society of America, the Trailblazer in Diversity and Equity Award from ABC-T (Association for Behavioral and Cognitive Therapies), and last year she was inducted into her undergraduate university's Health Care Hall of Fame at Union Commonwealth University. Her dissertation addressed the barriers of administrative burden as experienced by late-diagnosed autistic women. She achieved her PhD at age 65, after supporting her autistic son through his own educational journey.
